

HOLD HARMLESS AGREEMENT FOR NON-CADDO PUBLIC SCHOOLS

full responsibility for myself and my child, and do agree to indemnify, save and hold harmless and defend the Caddo Parish Sheriff, Henry Whitehorn, Sr., and all of his employees and agents, acting officially or otherwise, from any and all liability, claims, demands, actions, judgments, expenses, costs, interest, debts and attorney's fees arising out of, claimed on account of, or in any manner predicated upon or injury, or loss of life of any person or damage to the property of any person or persons whatsoever, including myself and/or my child, or any third party, which may occur resulting from the participation of myself and/or my child in any program conducted at Sheriff's Safety Town (8910 Jewella Avenue, Shreveport, Louisiana 71118). The purpose of this program is to provide participants with a general understanding of pedestrian safety, bicycle safety, motor vehicle safety, school bus safety, railroad crossing safety, fire safety, electrical safety, gun safety, "Stranger Danger," and 9-1-1 familiarization.

I understand and agree that participation in a program at Sheriff's Safety Town will include, though not be limited to riding bicycles, operating a small electric vehicle, riding on a seatbelt simulator, and I/we have been apprised of and understand the liabilities and hazards of participating in this event. Also, I believe that the benefit of my child gaining a general understanding of the above noted areas of safety far exceeds any potential risk. It is further agreed that the undersigned, our successors, estates heirs and assignees will refrain from holding the Caddo Parish Sheriff, Henry Whitehorn, Sr., his employees or agents responsible for any damages arising from loss of property, personal injury or death, loss of access to property or other consequential damages as a result of participating in a program at Sheriff's Safety Town.

In an effort to keep the citizens of Caddo Parish informed of public safety-related initiatives promoting community participation in locally offered camps and programs, the Caddo Parish Sheriff's Office and Sheriff's Safety Town operate web sites/pages and utilize social media (i.e. Facebook, Twitter, etc.). I understand and agree that my/our child may be photographed or videoed and those images of my/our child may be used on the Caddo Parish Sheriff's Office and/or Sheriff's Safety Town websites and social media sites.
